1. BANKERS INSURANCE COMPANY or ALLEGHENY CASUALTY COMPANY as bail, shall have control and jurisdiction over the Defendant during the term for which the bond is executed and shall have the right to apprehend, arrest and surrender the Defendant in the proper officials at any time as provided by law.
2. In the event surrender of the defendant is made prior to the time set for Defendant appearances, and for the reason other than as enumerated below in paragraph 3, then Defendant shall be entitled to a refund of the bond premium.
